




PORTFOLIO OBJECTIVE

Investments to be included in the 4D Met Aggressive Flexible Fund of Funds will, apart from assets in liquid form, consist soley of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide the investor protectional least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others equity securities, property securities, non-equity securities, market instruments, preference shares and bonds. The manager shall have the maximum flexibility to vary assets between various markets and asset classes to reflect changing economic and market conditions.


