
- INVESTMENT OBJECTIVE



RISK PROFILE



Low | Low - Medium

Medium | Medium - High

- These portfolio's generally hold more equity exposure than low risk portfolio's but less than high risk portfolios.

 In turn the expected volatility is higher than low risk portfolios, but less
- than high risk portfolios.
 The probability of losses are higher than that of the low risk portfolios, but
- less than high risk portfolios.
 Expected potential long term investment returns could therefore be lower
- than high risk portfolios due to lower equity exposure, but higher than low risk portfolios.

- High
 Generally these portfolio's hold more equity exposure than any other risk profiled portfolios therefore tend to carry higher volatility.
- Expected potential long term returns could be higher than other risk profiles, in turn potential losses of capital could be higher.


