

The 4D Met Cautious Fund of Funds is a cautious managed fund of funds portfolio. The primary investment objective of the portfolio is to provide the investor with a high level of income while preserving capital in real terms.


### INVESTMENT STRATEGY

Investments to be included in the 4D Met Cautious Fund of Funds will, apart from assets in liquid form, consist soley of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide the investor protectional least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others equity securities, property securities, money market instruments, preference shares and bonds. To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. The composition of the portfolio shall reflect the investment structure of a retirement fund with a cautious risk profile and will comply with prudential guidelines.


