

Investments to be included in the 4D Met Moderate Fund of Funds will, apart from assets in liquid form, consist soley of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide the investor protectional least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares and bonds. The composition of the portfolio shall reflect the investment structure of a retirement fund and shall comply with prudential guidelines.


