INVESTMENT OBJECTIVE

The primary investment objective of the portfolio is to provide the investor with a moderate level of income and capital growth.

The underlying portfolios may invest in, amongst others, equity securities, property securities, non-equity securities, interest bearing securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.




